TERMS AND CONDITIONS | October 17-18, 2009

Release and Waiver: Oregon BASS Federation ("Promoter"), show management or any show employees will not be responsible for any injury, loss or damage from any cause whatsoever that may be suffered by an exhibitor, his employee or property. The Exhibitor, upon execution of this Agreement, expressly releases the foregoing named parties and individuals from any and all claims for such loss, damage or injury and agrees to hold harmless and indemnify Oregon BASS Federation, for any loss. Any and all laws of the County of Marion in the State of Oregon must be observed by the Exhibitor, including all applicable sales tax laws.

Booth Assignment: Booth assignment is based on a first come basis only after signed contract and payment in full has been received.

Contract Acceptance: Signature by Exhibitor on this Agreement and acceptance of Exhibitor contract shall constitute acceptance under this Agreement.

Restrictions on Booth Space User: Exhibitor shall not sublet or share his exhibit space with another Exhibitor or organization without express written permission of Promoter. Exhibits must remain within the defined booth space, not extend more than 10ft above the floor at the rear of an exhibit and not obstruct the view, or disadvantageously affect the display of other Exhibitors. Food and beverages may not be sold in booths except Pre-Packaged Sealed foods with express written permission of Promoter. Exhibitor producing sound may not annoy or disturb adjacent Exhibitors. Promoter reserves the right to determine appropriate sound levels.

Booth Equipment and Privileges: Each booth purchased shall include standard 8' back and 3' side drapery, (1) 8ft table and electricity. Exhibitors requiring additional tables and chairs are encouraged to bring their own or rent them from the exhibit company. Each 10 x 10 booth shall be provided 2 Exhibitor passes.

Set-up and Removal of Exhibits: Setup will begin at 10:00 a.m. on Friday, October 16, 2009. All exhibits must be set up by 8:30 a.m. on Saturday, October 17, 2009. Booths must remain staffed at all times during the Expo's duration. No Booths may be removed prior to 5:00 p.m. on Sunday, October 18, 2009. All Exhibitor property must be removed no later than 10:00pm on Sunday, October 18, 2009.

Liability: Exhibitor is responsible for booth space and shall not deface the premises with the use of pins, hooks, tacks, nails, or screws into the wall or floor. Exhibitor shall not affix any signs to the walls or windows nor use adhesive material on any painted surface. Furthermore, all automobiles and recreational vehicles must have drip pans or protective covering under them to protect the floor stains.

Installation: Any booth that will require any special wiring, electrical, carpentry, and water or drainage connections shall be installed at the Exhibitor's expense in accordance with the requirements of Oregon State Fairgrounds and Expo Center. Exhibitor is responsible for any damage which may occur from installation of such items and will hold the Promoter and Oregon State Fairgrounds and Expo Center harmless from liability and/or claims.

Firearms Declaration: Firearms may be brought into the building only with written permission of Promoter.

Running of Engines: Gasoline, diesel, propane or oil engines can not be operated during the event.

Insurance: Exhibitor is responsible for obtaining workers' compensation, commercial and general liability insurance. Promoter will take certain precautions against theft or other emergencies, but Promoter does not guarantee or insure against loss from theft or damage. Neither the Promoter or Oregon State Fairgrounds and Expo Center shall be responsible for loss or damage sustained by the Exhibitor from any cause which may arise out of or as the result of the Exhibitor's activities. If Exhibitor desires insurance on such losses, the Exhibitor should obtain such insurance at its own expense

Cancellation: Deposits are non-refundable. In the event that performance of this contract becomes impossible because of an Act of God, action by governmental authority, civil unrest, war, terrorism or other similar circumstances, beyond the control of the non-performing party, the event shall be rescheduled at a later date. In the event of cancellation or delay the Exhibitors damages shall be limited to the deposit received by Promoter.

Photography and Video: For future shows, Exhibitor hereby acknowledges and consents that Promoter will be taking photographs and video at the Sportsman's Expo. All such photographs shall be royalty-free and the sole property of the Promoter.

Security: Promoter will provide 24-hour security during the Expo. Exhibitor agrees to "hold harmless" the Promoter, the Oregon State Fairgrounds & Convention Center and their respective personnel for any damage, injury or loss to any person or property for any cause, directly or indirectly related to participation in the Exhibition. If the Oregon State Fairgrounds & Convention Center or its contents shall be destroyed or damaged by fire or other cause, the Exhibition is interrupted or prevented, then the Exhibitor waives any claims for damages or compensation, consequential or otherwise, which might arise by reason of the prevention or interruption.

EXHIBITORS MUST COMPLY WITH ALL CITY, STATE AND FEDERAL LAWS, ORDINANCES AND REGULATIONS. EXHIBITORS MUST HAVE IN THERE POSSESSION AT THE TIME OF THE SHOW ALL NECESSARY CITY, STATE, OR FEDERAL LICENSES AND/OR REQUIRED PERMITS.

This Agreement constitutes an Agreement between Exhibitor and Promoter and shall be binding on the heirs and successors of each party.

This agreement shall be governed by the laws of the State of Oregon and any dispute regarding this Agreement shall be litigated in the State of Oregon.
